- 5) **Estimated cost of Tender: Rs. 10.00 Lakhs.**
- 6) **E.M.D.:** An EMD of 1% of the Tendered value, of **Rs.10000/-** shall be paid Cash/ Online / Demand Draft/Bank Guarantee in favour of Maharashtra State Electricity Dist. Co. Ltd drawn on any Nationalised / Scheduled Bank. The scanned copy of the receipt for Demand Draft submission should be uploaded during online submission of the bid. D.D. / B.G. towards EMD is to be submitted at the office of Executive Engineer, MSEDCL, Urban DIVISION-I, CHH.SAMBHAJI NAGAR on or before due date & time of Tender submission.
Tenders submitted without EMD are liable to be rejected. *Agencies claiming exemption from payment of EMD shall give sufficient proof in support of their claim*
Interest shall not be paid on E.M.D. Earnest Money Deposit shall be forfeited in case-
 - i) The tenderer withdraws the tender/offer during the validity period or-
 - ii) The tenderer fails to pay the Security Deposit if the contract is awarded.
- 7) **Refund of E.M.D. to unsuccessful tenderer:**
Earnest Money Deposit shall be returned to the unsuccessful tenderer's as soon as possible after the tender is finalized by the Company.
- 8) **Tender Fee:** The bidder has to pay tender fee of **Rs. 1180/-** (non-refundable). *Agencies claiming exemption from payment of tender fees shall give sufficient proof in support of their claim*
- 9) Only online payment will be accepted for the tender fees. Tender documents can be downloaded from our website

- (<http://works.mahadiscom.in/eTender/etender>) immediately if the online payment is successful. Agencies claiming exemption from payment of Tender Fee shall give sufficient proof in support of their claim.
- 10) The tender is available on Website shown in Tender Details, through E-tendering System only. All the required documents for Technical & Commercial Bid should be digitally signed before uploading “online” There should be no over-writing. It should be avoided and in case correction are necessary the earlier matter should be scored and initialled with new details . Tender not signed as above shall be liable to be rejected.
 - 11) The successful Tenderer shall be required to pay security deposit amounting to 10% of the value of the contract either by DD/Pay Order, OR Bank Guarantee etc. valid for period of contract towards quality of work performance.
 - 12) Before submitting their offers the tenderer shall examine closely all documents which form part of the contract to be entered into.
This is a work to be executed according to the schedule enclosed by providing services required for the work. The tenderer is requested to inspect the area / site, particularly the roads and see for himself the site conditions regarding approaches, material, water supply labour etc. and all the other matter affecting the work before filling the tender. In this connection the tenderer may contact concern SDOs before submission of the tender.
 - 13) **The tenderers should be registered with the Government of Maharashtra as an Electrical contractor.** Documentary evidence should be submitted along with tender. The licence number has to be clearly indicated in the tender. Preference will be given to the tenderer having experience in similar type of job.
 - 14) The Contractor shall be required to pay the labourers engaged by him on the work not less than a Minimum wage (which expression shall mean whether for whole time or piece work the respective rates of wages as fixed under the law for the time being in force) The contractor shall, be required notwithstanding any provisions in the contract to the contrary, cause to be paid such Minimum Wages to labourers indirectly engaged on the work, including any labour engaged by his labour contractors in connection with the said work as if labourers had been immediately employed by him. The contractor shall comply with provisions of payment of Wages Act, 1936, Minimum Wages Act, 1948, Employees Liability Act 1938, Workmen’s Compensation Act 1923, Industrial Disputes Act 1947, Indian Factories Act 1948, Maternity Benefit Act 1961, E.P & M.P Act 1952 and Contract Labour (Regulation and abolition) Act 1970 or any modification thereof or any other law relating thereto and rules made there under from time to time, and give effect to the provisions of any law for the time being in force and regulating the rights and privileges of the labourers employed by him directly or indirectly. The Tenderer will have to furnish the documentary confirmation that facilities are made available to the employees engaged by him on the job. The contractor shall indemnify the MSEDCL. against any payments to be made under and for the observance of the regulations, for the time being in force without prejudice to his right to claim indemnify from his subcontractor.

- 15) List of manpower with mobile number and Aadhar card no. is to be submitted before issuing of work order/LOA by qualifying agency.
- 16) The contractor shall be responsible for rectification of defects for the work carried out during period of contract. Any defects or failures during this period shall be rectified within one week of intimation in writing. If the same is not carried out in the stipulated time, we shall have the right to get it repaired departmentally or through any other agency. The cost of the same shall be recovered from the contractor. The S. D. amount (10% of the contract value) paid by the agency either through Demand Draft OR in the form of Bank Guarantee will be released only after completion of this above said period subject to submission of certificate from Field Additional-Executive Engineers under Urban-I Division, CHH.SAMBHAJI NAGAR.
- 17) If the tenderer has any doubt about the meaning of any portion of the tender he should at once get clarification from Addl. Executive Engineer, Urban-I Division, CHH.SAMBHAJI NAGAR in writing sufficient in advance and also personally meet him in this respect before the due date. No additions or alterations in the tender form / conditions etc. should be made by the Tenderer. Tenderer should either quote his item rates for the works described in the schedules or write the words "**RATE NOT QUOTED**" against concerned items.
- 18) The tenderers must upload (online submission) the forms of schedules duly filled in with rates in figures and in words and each schedule duly signed. Any schedule not bearing the signature of the Tenderer, the tender is likely to be rejected. Rates quoted for work should be reasonable. Only one rate should be quoted. In case dual rates are quoted for the same, item the offer is likely to be rejected. Tenderers should not offer rates for items not covered in the schedules and also should not split any item of the schedule. Doing so, may disqualify from the offer. Discount on any account such as quantitative discount, payment discount etc., will not be considered for comparison of the rates, as such, rate should be on firm quotation basis only.
- 19) Special attention is invited to the requirements that all corrections must be initiated and dated by the tenderer and that all the pages should bear the full signature of the tenderer at the foot of each page and each schedule should bear the seal of the tenderer.
- 20) Tenders which do not fulfil all or any of the above conditions or incomplete in any respect are liable to be rejected.
- 21) The submission of a tender by a tenderer implies that he has read these instructions the conditions of contract etc., After acceptance of the offer we shall not pay any extra charges for the lead or for any other reasons in case the Tenderer is found later on to have misjudged himself.
- 22) Tenders shall remain open for acceptance for a period of 90 days from the date of opening of the tender. During this period no tenderer shall be allowed to withdraw his offer. Any such with-drawl during the said period will entail forfeiture of the Earnest Money deposited with us.
- 23) The Tenderer should furnish details of his organisation, technical experience, equipment and financial capacity to carry out the works set out in the tender within the time stipulated for completion, if required by MSEDCL. He shall furnish details of value of works, authority under whom it was executed and period of completion.

- 24) The contractor may have their office/Contact person in area under **Urban-I, Division, CHH.SAMBHAJI NAGAR**. The address along with the name of Contact person and Telephone number should be furnished along with the offer.
- 25) The Tenderer will have to submit Net worth Certificate for last financial Year. (Positive Net worth required for this tender)
- 26) Any Taxes on material / works or on transfer of property in goods involved in the execution of work contract or any other material or on furnished any fabricated material or work shall not be separately paid as an addition to the Tender rates by the Company. The rates for several items of work indicated are deemed to include all local and general taxes, excise duty etc.
- 27) A copy of work contract registration should be enclosed; if not the Work Contract tax as specified by the Government will be deducted directly from Contractor's bill.
- 28) Income Tax & other Taxes as applicable from time to time will be deducted from the bills of the agency.
- 29) The contractor on placement of the work order enumerating the contract condition shall within the prescribed period have to execute a written agreement on the prescribed standard form as per Company's Rules. The regular stamp fees etc necessary for completing the agreement shall have to be borne by the contractor.
- 30) The Contractor shall not entrust the work on sub contract, transfer or assign the contract or any part thereof to any other party without consent / permission from **Undersigned**. In case if it is not followed it will be treated as breach of contract and will be terminated at contractor risk and cost.
- 31)(a) The firm / contractor must arrange for all transport of material and include all such cost in the rates quoted by them for work.
 (b) The schedule of quantities as indicated in this tender are approximate AND minor deletions or additions may be possible while finalizing the Tender order.
 (c) The tenderer should furnish information regarding the works or similar nature carried out by him/them in any other department and submit copies of certificates in proof thereof.
- 32) General conditions of the Work Contract are as per Annexure "I" which shall form part of the contract. The contractor shall abide by the "General condition of Company's rules for contract.
- 33) The right to reject any or all the offers is reserved by us and we will not be bound to accept any offer without assigning any reason thereof.
- 34) In case of any dispute arising out of this contract, the decision of the **Undersigned** will be final.
- 35) Further information required if any can be had from the office of the **Undersigned**.
- 36) **Insurance and Payment of Contract Labour: -**
 Labour employed by you for execution of this contract should be covered under Workmen's Compensation Act and as required under the relevant provisions of the Contract Labour (Regulation and Abolition) Act. 1970. Insurance policy should be valid during entire period of this contract or extended period of the same if necessary.
 The Contractor shall be required to pay the labourers engaged by him on the work

not less than Minimum Wages (which expression shall mean whether for whole time or piece work the respective rates of wages as fixed under the law for the time being in force). The contractor shall be required notwithstanding any provisions in the contract to the contrary, cause to be paid such Minimum Wages to labour contractors in connection with the said work as if labourers had been immediately employed by him. The contractor shall comply with the provisions of payment of Wages Act 1936, Minimum Wages Act, 1948, employees Liability Act 1938, Workmen's Compensation Act 1923, Industrial Disputes Act 1947. Indian other law relating thereto to rules made there under from time to time and give effect to the provisions of any law for the time being in force and regulating the rights and privileges of the labourers employed by him directly or indirectly.

The contractor shall indemnify the MSEDCL against any payments to be made under and for the observance of the regulations, for the time being in force without prejudice to his right to claim indemnify from his subcontractor.

37) As per the Government of Maharashtra Resolution, contractors' all risk (CAR) insurance policy or Transit cum Erection (TCE) or Erection all risk (EAR) insurance in respect of contract works awarded by MSEDCL as principle to the contract work and workman's compensation insurance in respect of workmen engaged and deployed by the contractor's to complete contract work, is required to be obtained from the Director of Insurance, the Govt. of Maharashtra as per the Letter from H.O. vide No. IR/Insurance/9623 dtd.13/04/2012.

38) **Liquidated Damages:**

The essence of this contract is that the successful bidder issues the bills to the consumers in stipulated time period and also that the bill is absolutely correct in all respects. Thus, it will be mandatory on part of the Successful bidder to carry out the work of allotted quantity as per the scope (in totality) and as per the billing cycle of the respective SUB-DIVISIONs within the specified time. A weekly compliance shall be given by the Successful bidder to the respective Addl. Executive Engineer / nominated authority.

A. If the meter reading programme not operated as per schedule given by the concerned billing unit, a penalty of Rs 1,000/- per delayed day will be deducted from the bidder's bill.

B. If any discrepancies observed by MSEDCL while cross checking the bills, penalty @ Rs 250/- shall be recovered for each occurrence from the bidder's bill.

C. 100% of meter reading through CMRI otherwise penalty will be charged @ five times of scheduled rate for non-taking the reading. Also, in the case the Hon. Regulatory Commission penalizes MSEDCL, levies penalty/ fine on account of non-compliance of standard of Performance with respect to the bills issued under this contract

(delay or wrong bill or for any other reason pertaining to billing) and where you are responsible for this, the same penalty /fine will be to your account and it will be deducted from your bills. If the wrong billing exceeds 5% (in quantity) during a particular month, the contract is liable to be terminated and MSEDCL will be entitled to deduct/recover the amount of liquidated damages for the bills payable to you against this or any other zone for which

the order is placed to you. These LIQUIDATED Damages will be without prejudice to MSEDCL's rights of any other action/recourse permitted under the law. Levying of the liquidated damages will be applicable as per the directives from Head Office, Mumbai time to time. 100% Reading are to be taken by the agency, otherwise penalty will be @ **fivetimes** of rate for meter reading untaken images. B-30 reports of respective P.C. Should be got certified by concerned Assistant Accountant & S.D.O after validation of all status & before processing in I.T.

- D. All the amendments time to time by authority, in penalty clause shall be applicable to successful bidder.
 - E. These Liquidated Damages will be without prejudice to MSEDCL's rights of any other action / recourse permitted under the law.
 - F. Contractor must bring the correct meter reading & submit to MSEDCL with actual data, in case of any temperament to reading or wrong reading penalty should be charged @ 5 times of rate of meter reading for number of meter readings not brought by the contractor for each consumer.
 - G. If it is noticed that the bogus readings are shown without visiting the consumers premises & Such bills are issued to consumers, the agency shall be instructed to lodge FIR against his employs who is indulged in such activity.
 - H. Bill must be distributed immediately after handing over energy bills to the contractor or before 3 days of prompt payment date. In case contractor fails to distribute bills Rs. 20/- penalty per bill will be deducted from his claimed bill and If any complaint received against non-distribution of bills & If it is proved then FIR will be filed against the contractor.
 - I. If repeated mistakes are observed against the same agency, this shall be treated as utter failure of it and FIR will be filed by concern billing incharge/SDO/contract shall be terminated with black listing of the same as per rules and regulations of MSEDCL.
 - J. If the Contract is terminated at the Employer's convenience or because of breach of Contract by the Employer, the Employer is to issue a certificate for the value of the work done, materials ordered, the reasonable cost of removal of equipment, repatriation of the Contractor's personnel employed solely on the Works, and the Contractor's costs of protecting and securing the Works and less advance payments received up to the date of the certificate.
- 39) If any agency is qualified for the work under Powerhouse subdivision, then the same agency will not be allotted the work order for other subdivisions i.e. Shahaj, under urban division no.1.
