GENERAL TERMS AND CONDITIONS

1. The schedule of work & estimated cost as mentioned is purely tentative & may vary as per the actual requirement on site.
2. All the interested Bidder who have registered on MSEDCL web site www.mahadiscom.in from 18.04.2024 shall read carefully all the pre-qualifying documents requirement and fill up the pre-qualify bid no. 1) on online duly digitally signed and completing the requirement of documents as per prescribed proforma.
3. The Bidder should quote the rates of each items mentioned in the schedule attached with the Tender with exclusive of all taxes. The rates quoted for extra item other than schedule enclosed by any Bidder will not be considered.
4. The rates shall be valid for 90 days period from the date of opening of bid.
5. Duly filled in and duly e-signed (digital signed) price bids should be uploaded mentioning all the required details under two separate bids 1) pre-qualifying bid and 2) price bid through e-Submission process maximum up to date 29.04.2024 up to 18.00 hrs.
6. Since tender submission process is through e-submission only, no tender box will be kept in office for manual submission as per earlier process, same may please be noted. If any discrepancy is observed between the amount in figures & in words, the amount whichever is lower will govern.
7. The contractor who fails to start the works within the schedule time and date will be liable to forfeit of the earnest money deposit or security deposit paid, in addition to the compensation to the MSEDCL as per the terms & conditions of the contract.
8. If it is found that quality of works as well as performance is unsatisfactory, the contract is liable for termination without giving any notice. The security deposit paid in cash shall be forfeited. The entire work under this contract would be subject to general conditions of contract for work and terms and condition of contract stipulated therein would be binding on contractor.
9. The contractor should not entrust the work on subcontract or transfer or assign the contract or any part thereof to any third party in case if it is not followed it will be treated as break of contract and will be terminated at contractor's risk & cost.
10. The entire work under this contract would be subject to general conditions of contract for work and terms and condition of contract stipulated therein would be binding on contractor.

11. The contractor should have his own man power and vehicle required to carry out the job. In case of any accident to his worker the total responsibility lies with the contractor.
12. In case of damage to the MSEDCL's material/theft of material, then appropriate cost of the same will be recovered from the contractor.
13. The work shall be carried as and when allotted by the Executive Engineer, KALYAN RURAL DIVISION. The completion period of ascertained work will be decided by the concerned Executive Engineer.
14. All the works shall be carried out as per the instruction of this office.
15. The contractor will have to start the work as per instruction of Ex.Engineer. Kalyan Rural Division or his authorized representative after getting the order from this office and completion of formalities.
16. If any defects observed to material during the transportation then the amount of damage will be recovered from the contractor.
17. In case the work is not fully carried out by the contractor the MSEDCL will get done the work through some other parties at high rates and difference of rates shall be recovered from the contractor's bills who fail to execute the order and also the E.M.D. /S.D. etc. will be forfeited in breach of contract which may be please noted.
18. The bills should be submitted through the Executive Engineer in triplicate for the payment after completion of complete work to this office. The bill will be paid by cheque only as early as possible after receipt of bill along with entry in SAP to this office, subject to availability of funds.
19. The contractor shall not be entitled to claim any interest, any arrears or on balance amount which may be found due to him at any time.
20. The Income tax &necessary taxes as applicable as per prevailing rate will be deducted from the bills.
21. Period of Contract: Initially the period of contract will be for one year or completion of order value whichever is earlier and subject to further extension on mutual consent if found necessary.
22. You are also deemed to be fully aware of Company's General terms conditions of works contract, and any ignorance of these terms and conditions will not be accepted. The Sub-station area is declared as prohibited area by the Company it is necessary to take the prior permission from the work in charge for entry etc. The safety of your personnel executing the work shall be fully confirmed prior to undertaking the work and responsibility of safety for your staff /persons shall lay with you.
23. You will be totally responsible for the safety of your persons while transporting material and Company will not be responsible for any damage to your vehicle, material/ manpower etc.
24. No accommodation will be provided to you or to your persons by Company.
25. No T&P/labour, Crane any other relevant equipment will be provided by the Company. Therefore, the same will be arranged by you.

26. Amount/ Amounts due on account of damage or transportation delay or default or breach of contract, the right to recover-retain or withheld the same is reserved by the Company. Any type of compensation/ damage etc. to your labour or persons due to any accident etc. will have to be paid by you and Company will not be responsible for the same.
27. All necessary precautions should be taken while carrying out the work so as to reach the material safely at S/Dn. Store/Site. In case of any damage to the MSEDCL's material/theft then appropriate cost of the same will be recovered from the contractor.
28. The contractor shall have to complete the work within 02 days from the intimation from this office or authorized representative of this office. If in case the contractor fails to carry out the work in stipulated time, the penalty @ ½ % per week for the delayed period will be charged maximum up to 10% of the value of the contract order.
29. The contract or any parts thereof shall not change without the permission of accepting authority or his authorized representative.
30. Earnest Money Deposit: - The contractor will have to pay E.M.D. at the rate 1% of tender value, as mentioned, to this office in the form of D.D. drawn of any Schedule/Nationalized bank in favor of Executive Engineer O&M MSEDCL, Division Kalyan R payable. Tenders without payment of EMD shall not be considered and will be liable for rejection.
31. The Bidder shall have to pay security deposit amounting @ 10% of the value of the order within 14 days from the date of receipt of the LOA and before starting the work in form of DD/B.G. The same will be refunded after completion of guarantee period. Security Deposit will be interest free.
32. If any discrepancy/objection found in the Tender documents regarding specifications etc., should be brought to the notice of this office before submission of Tender. No objection will be allowed/ entertained once the bids are opened. The decision of undersigned will be final & binding on all Bidders.
33. In case of any conflicting instructions or in difference of opinion on any point or in case of dispute about the contract/work order, the decision of the undersigned will be final & binding on you.
34. The contractor will have to execute and sign an agreement as per rules of MSEDCL on the stamp paper of Rs.100/- and will have to bear the stamp duty for the purpose if required.
35. The details of works to be carried will be given by concerned division in charge.
36. The terms and conditions mentioned in the tender notice is applicable to the Bidder.
37. The undersigned reserved the right to accept or reject tender without assigning any reason & to make any alteration / modification if necessary Further the undersigned reserves the right to bifurcate the tender order & work to more than one contractor.
38. Arbitration: -
The matters to be determined by the Executive Engineer (E.E.):-
All disputes & difference of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after its completion & whether before or after the determination of the contract, shall be referred by the contractor to the E.E. & E.E. shall (within 120 days) after receipt of the contractor's representation make & notify decisions of all matters referred by the contractor in writing.

a) **Demand for Arbitration :**

In the event of any dispute or difference between the parties hereto as to the construction or operation of this contract, or the respective rights & liabilities of the parties on any matter in question, the dispute or difference on any account or as to the withholding by MAHARASHTRA STATE ELECTRICITY DISTRIBUTION COMPANY of any certificate to which the contractor may claim to be entitled to, and if the E.E. fails to make a decision (within 120 days) then in any such case, the contractor (after 120 days) but within (180 days) of his presenting his final claim on disputed matters, shall demand in writing that the dispute or difference to be referred to arbitration.

- b) The demand for arbitration shall specify the matters, which are in question, or subject of the dispute or difference as also the amount of claim item wise. Only such dispute(s) or difference (s) in respect of which the demand has been made, together with counter claims or set off shall be referred to arbitration & other matters shall not be included in the reference.
- c) The arbitration proceedings shall be assumed to have commenced from the day, a written & valid demand for arbitration is received by the Board/ company.
- d) The claimant shall submit his claim stating the facts supporting the claims along with all relevant documents & the relief or remedy sought against each claim within a period of 30 days from the date of appointment of the Arbitral Tribunal.
- e) The Board/Company shall submit its defense statement & counter claims , if any within a period of 60 days of receipt of copy of claims from the Tribunal thereafter unless otherwise extension has been granted by the Tribunal.
- f) No new claim shall be added during the proceedings by either party. However, a party may amend or supplement the original claim or defense thereof during the course of arbitration proceedings subject to acceptance by Tribunal having due regard to the delay in making it.
- g) If the contractor(s) does/do not prefer his/their specific and final claims in writing, within period of 90 days of receiving the intimation from the Board/Company that the final bill is ready for payment, he/they will be deemed to have waived his/their claims(s) & the Board/ Company shall be discharged & released of all liabilities under the contract in respect of these claims.

39. Disputes:

Any disputes or differences arising under, out of or in connection with this tender or contract if not concluded shall be subject to exclusive jurisdiction of courts in Kalyan City of Maharashtra State. The Indian laws shall govern the contract.

40. Obligation during tendency of Arbitration :

Work under the contract shall unless otherwise directed by the Executive Engineer, continue during the arbitration proceeding, & no payment due or payable by the Board / Company shall be withheld on account of such proceedings, provided however it shall be open for Arbitral Tribunal to consider & decide whether such work should be continued during arbitration proceedings.

- a) In case where the total value of all claims in question added together does not exceed 20.00 Lac (Twenty Lac's) the Arbitral Tribunal shall consist of a Sole Arbitrator who shall be either the E.E. of the Board/Company or serving or retired officer of the Board/Company/Government not below the grade of S.E. or equivalent nominated by the Chairman of the Board/Company in that behalf. The Sole Arbitrator shall be appointed within 60 days from the day when a written & valid demand for arbitration is received by the Board/Company.

- b) In cases the value of the claim exceeds 5.00 Lakh (Five Lakh) as above; the Arbitral Tribunal shall consist of panel of 3 serving or retired officers of MAHARASHTRA STATE ELECTRICITY DISTRIBUTION COMPANY LTD. Govt. not below the grade of E.E/Dy.M (F&A) as the Arbitrators. For this purpose, the Board / Company will send a panel of more than 3 names of arbitrators of one or more department of the Board/Company/Govt. to the contractor who will be asked contractor's nominee. The Chairman shall appoint at least one of them as the contractor's nominee & will also appoint the balance number of arbitrators either from the panel or from outside the panel duly indicating the presiding arbitrator from amongst the three (3) arbitrators so appointed. While nominating arbitrators, it will be necessary to ensure that one of them is or has worked in Accounts Department.
- c) If one or more arbitrators appointed as above refuses to act as arbitrator, withdraws from his office as arbitrator or vacates his/their office/offices or is/are unable or unwilling to perform his functions as arbitrator for any reason whatsoever or dies or in the opinion of the Chairman fails to act without undue delay, the Chairman shall appoint new arbitrator's to act in his/their place in the same manner in which the earlier arbitrator's had been appointed. Such reconstituted Tribunal, May as its discretion proceeds with the reference from the stage at which it was left by the previous arbitrators (s).
- d) The Tribunal shall have powers to call for such evidence by way of affidavits or otherwise as the Arbitral Tribunal shall think proper, and it shall be the duty of the parties to do all such things as may be necessary to enable the Arbitral Tribunal to make the award without any delay.
- e) While appointing arbitrator(s) as above, due care shall be taken that he is /are not the one/those who had as opportunity to deal with the matters to which the contract relates or who in the course of his/their duties as Board/Company's servant(s) expressed views on all or any of the matters under dispute or difference. The proceedings or the Arbitral Tribunal or the award made by such Tribunal will, however not be invalid merely for the reason that one or more arbitrator had, in the course of his service, opportunity to deal with the matters to which the contract relates or who in the course of his their duties expressed views on all or any of the matters under dispute.
- f) Arbitral award shall state item wise, the sum & reasons upon which it is based.
- g) A party may apply for corrections of any computational errors, any typographical or clerical errors or any other error of similar nature occurring in the award & interpretation of specific point of award to tribunal within 30 days of receipt of the award.
- h) A party may apply to Tribunal within 30 days of receipt of award to make an additional award as to claims presented in the arbitral proceedings, but omitted from the arbitral award.
- i) In case of the Tribunal, comprising of three members any ruling or award shall be made by a majority of Members of Tribunal. In the absence of such a majority, the views of the Presiding Arbitrator shall prevail.
- j) Where the arbitral award is for payment of money, no interest shall be payable on whole or any part of the money for any period till the date on which the award is made.
- k) The cost of the arbitration shall be borne equally by the respective parties. The cost shall include fees of the arbitrators as per the rates fixed by the Board/Company from time to time.

j) Board/Company shall maintain a list of arbitrators. The Chairman shall have full powers to delete or add the name of the arbitrators in the list or to make amendments to the said list as per his discretion. The arbitral proceedings should be completed & the award be finalized within one year from the date of appointment of arbitrators. Subject to the provisions as aforesaid, Arbitration & Conciliation Act 1996 & the rules there under, & any statutory notification thereof shall apply to the arbitration proceedings under this clause.

41. Octroi Duty:

Material is to be transported outside the Municipal Corporation limit should be done under the provisions of the Octroi rules. The Municipal transport charges, if any, shall be borne by the contractor whenever the vehicles of the transport contractor have to pass through any Municipal area to the Consignee's Stores. The contractor shall however furnish all details of Octroi charges & Municipal transport charges well in advance.

42. Reimbursement:

a) Whenever payable by the Company Octroi Escort/Town duty and other necessary charges up to 500 will be paid by the contractor and same will be reimbursed to him with the bill payments for this contractor have to submit separately the details of such payments with the bills.

1. All the interested Bidder who have registered on MSEDCL web site www.mahadiscom.in from 18.04.2024 shall read carefully all the pre-qualifying documents requirement and fill up the pre-qualify bid no. 1) on online duly digitally signed and completing the requirement of documents as per prescribed proforma. All the details of tenders, instructions to Bidders, contractor's particulars. General terms and conditions, special conditions of contract, material to be used & Technical specification and schedule "A" is available on our web site <http://works.mahadiscom.in/eTender/etender>. Last date and time of submission of tender, only by e-submission process, is 29.04.2024 up to 23.30 Hrs. Manual submission of tender is not allowed and will not be accepted in any case or on any grounds whatsoever it may be. Bidder should take proper care to upload their tender through e-process well in advance before last date & time of submission to avoid last minute trafficking at server or any other computer/internet problem.
2. Duly filled in and duly e-signed (digital signed) price bids should be uploaded mentioning all the required details under two separate bids 1) pre-qualifying bid and 2) price bid through e-process maximum up to date 29.04.2024 up to 23.30 hrs.
3. Since tender submission process is through e-submission only, no tender box will be kept in office for manual submission as per earlier process, same may please be noted.
4. 6. Any conditional tender may not be considered.
7. The contract will be placed for one year.
8. All T & P's, Labours, Vehicles, Fuel, RTO Formalities etc. are to be arranged by the tender.
9. Price fluctuations clause will not be considered.
10. All offers shall be kept open for acceptance for 90 days from the date of opening of the tender.
11. Your tender will not be considered if you fail to furnish all the information required in the tender form.
