**I. PRICE: -**

Prices are acceptable only at F.O.R. destination basis inclusive of risk in transit and freight paid basis showing the break up as desired in schedule 'A'. It shall be noted that offers not conforming to F.O.R. destination basis and to the unit as specified in Schedule 'A' shall not be considered even though they may be the lowest. MSEDCL reserves the right to accept or reject any of the offers submitted by the bidder without citing any reasons thereof In addition the sample needs to be approved by committee for the quality as per the specification vides schedule A. **The cost of tender is Rs. 2.00 Lakhs (Rupees Two Lakhs only).**

**II. EXCISE DUTY: -**

Excise duty will be paid extra, if applicable and agreed to in the contract, at the rates applicable at the time of dispatch (within the contractual delivery period) on Ex-works prices to be indicated by the supplier against copy of E.D. gate pass. Benefits due to further changes in MODVAT system, if any, should be passed on to M.S.E.D.C.L.

**III. Goods & Service Tax (GST):**

**VI. QUOTATION: -**

- 1) Supplier shall quote his rate per unit specified in schedule 'A' in figures as well as in words. Any variation in the rates etc. will not be allowed on any ground such as mistake, misunderstanding etc. after the tender has been submitted. The tendered rate must include in general (a) all charges for container and packing (b) all charges to effect F.O.R. destination of the supplies.
- 2) Suppliers printed terms and conditions will not be considered to form part of the Tender.
- 3) In case of divergence between the rates in figures and words, it will be considered to read the rate most favorable to the MSEDCL.
- 4) The above rates should be quoted including Sales Tax & all other taxes & duties as per government rule.
- 5) GST will be paid Extra as per government rule.

**VII. AMBIGUITY IN QUOTATION: -**

Suppliers are requested to please make a note that in case of ambiguous terms in respect of F.O.R. destination condition excise duty, sale tax/VAT or if the blanks are not filled in/unanswered; the offer/tender shall be liable to be rejected.

**VIII. FILLING IN OF QUESTIONNAIRE: -**

The MSEDCL does not bind itself to accept the lowest offer or else with any reasons be assigned for the rejection of any tender or part of tender. It is also not binding on the MSEDCL to disclose any analysis report on tender/samples. The supplier on his part binds himself to supply any item or items selected from his offer in part or at the option of the MSEDCL.

The MSEDCL reserves the right to order /procure any quantity in excess to the extent of 50% or part of the quantities offered by the supplier.

**XVII. SUBMISSION OF SAMPLES: -**

Wherever mentioned, the sample of item offered shall be presented to this office as on before date of submission of bid. The samples submitted should be strictly confirming to the specification and drawing of the material offered. If the sample is found to be not as per the specifications, drawings, the offer will not be considered and no correspondence from the supplier for accepting actual supplies conforming to MSEDCL's requirement will be entertained. The un-successful supplier, on notification, shall collect the sample within 30 days from the date of notification at their cost, failing which the sample will be treated as company's property without any payment and any further notice. The sample send should be approved by MSEDCL committee before opening the tender. On non-approval, the price bid of that bidder will not be opened and the offer will be rejected.

**XVIII. EARNEST MONEY DEPOSIT: -**

Notwithstanding that the supplier is registered with the MSEDCL under different classes A, B, & C, suppliers should pay the Earnest Money at 1% (one percent) of the total value of the tender subject to minimum of **Rs. 2000/-** unless the firm is exempted on account of statutory directives. **XXI. DELIVERY: -**

The different types of Aluminum Lugs are to be supplied at MSEDCL Store Centre Netiwali. Tenderer is requested to quote for deliveries at our stores only.

The supplier should quote clear delivery period in Schedule 'A'. Offers with qualified delivery schedule which directly or indirectly affects conditions of tender and supply shall be liable for rejection.
