Online e-tenders are invited from reputed licensed suppliers & contractors experienced in the work of Renovation of Electrical Wiring, providing lighting fixtures at various offices & Annual electrical maintenance contract.

Tenderer must return the e-tender form together with the specifications and the rates duly filled in and other schedule duly signed. Any tender not bearing the signature of tenderer on all the documents accompanying the tender is liable to be rejected. The tenderer shall also fill up the **PARTICULARS OF TENDERER** and submit the connected documents with tender in Technical bid.

1. **Name of Work:** Renovation of Electrical Wiring, providing lighting fixtures & Annual Electrical maintenance at Admin Building Rastapeth and various offices under Rasta peth Division Pune.
2. **Period of contract:** Up to the completion of order value or 1 year whichever is earlier.
3. **Area of operation:** Admin Building Rasta Peth and various offices and substations under Rasta Peth Division Pune.
4. **Estimated Cost of Tender:** Rs. 5 Lakhs (Excluding Taxes).
5. **Tender Fee:** The bidder has to pay tender form fee of Rs.1180/- (non-refundable) online or in the form of DD/Cash. The DD/Cash, the payment towards tender fee is to be made in favour of Maharashtra State Electricity Distribution Co. Ltd. and the same is to be submitted to the office of Executive Engineer, Rastapeth Division on or before the due date and time of opening of technical bid. The scanned copy of the D.D/Cash Receipt is to be uploaded with the qualifying documents of the bid and the details of D.D/Cash Receipt towards tender fees are to be filled by the bidder during online submission of the bid.
6. **Earnest Money Deposit (EMD):** An EMD of 1% of the Tender value, i.e. Rs.5000/- shall be paid online or by Cash/ Demand Draft in favour of Executive Engineer, MSEDCL drawn on any Nationalized / Scheduled Bank situated in Pune. The scanned copy of this Demand Draft and receipt (if EMD paid in cash/DD) should be uploaded during online submission of the bid. D.D. towards EMD is to be submitted at MSEDCL, Rastapeth Division Office, on or before due date of submission.. Tenders submitted without EMD are liable to be rejected. Interest shall not be paid on Earnest Money Deposit (E.M.D.) and shall be forfeited in case-
 - i) The tenderer withdraws the tender/offer during the validity period or-
 - ii) if the bidder does not accept the correction of its bid price, i'e 'in case of discrepancy and or difference in the value between the quoted price in number and as expiessed in words as" a percentage above or below the estimate cost, the value as expressed in words shall prevail over the value as expressed in number for the determination of the Total price of the Bidder.
 - iii) if the bidder is determined, at any time prior to award of contract, to have

- engaged in corrupt or fraudulent practices in competing for the contract: or
- iv) in the case of a successful bidder, if it fails within the specified time limit to:
- (i) sign the Contract Agreement, or
 - (ii) furnish the required security deposit.
- v) in case of Joint Venture if there is any breach in the Joint Venture before finalization of tender & issue of LOA within original or extended period of validity of the bid. In this case the bid security submitted by both the partners shall be forfeited.
7. The tenders duly filled and duly signed by registered contractor shall be uploaded on the MSEDCL e tender website. Tenders will be opened online only at specified date and time. All the required documents for Technical & Commercial Bid should be signed/digitally signed before uploading "online". There should be no over-writing. It should be avoided and in case corrections are necessary, the earlier matter should be scored and initialed with new details. Tenders not signed as above shall be liable to be rejected.
8. Security Deposit: The successful Tenderer shall be required to pay security deposit within 14(fourteen) days of receipt of the Letter of Award amounting to 10% of the value of the contract either by DD/ unconditional and irrevocable Bank Guarantee issued by a Nationalized or Scheduled Bank in favour of the Executive Engineer, MSEDCL, Parvati Division. The bank guarantee shall, if invoked, be- en-cashable when presented in the branch office of such Bank located at local area. The format of the Bank guarantee shall be in accordance with the sample form of bid security'. The amount of security deposit shall be refunded only after the fullest satisfaction of the Employer at the completion of the contract period and after the completion of guarantee period.

9. Qualifying Requirement of the bidder :

The bidder shall fulfill following requirements:

In order to be qualified for award of Contract, the bidder will be required to satisfy the following minimum qualifying criteria, which take precedence over any qualification requirements that may be stated in the Specifications or elsewhere in the Bidding Document:

- (a) **General Experience:** The Bidder should have executed either i) one work order/contract (denotes executed only) equivalent to at least 20% of the Tender Estimated Cost, or (ii) two work orders/contracts (denotes executed only) equivalent to at least 25% of the Tender Estimated Cost or (iii) three work orders/ contract (denotes executed only) equivalent to at least 30% of the Tender Estimated Cost for the work carried out continuously during last 3 years in any one calendar year along with experience certificate certified by authority not below the rank of Executive Engineer;
- (b) **Specific Experience:** The Bidder should have prior experience in executing one work order/contract (denotes executed only) of similar nature of work in distribution sector/ system of a value equivalent to at least 15% of the Tender Estimated Cost, during the last three

financial years (i.e., FY 2020-21, 2021-22 & 2022-23).

- (c) **Average Annual Turnover:** The bidder should have an average annual financial turnover during the last 3 years (FY 2018-19, 2019-20 & 2020-21 or 2021-22) of at least 30% of the estimated cost of the tender.
- (d) the Bidder should have a **positive Net Worth** (which is defined as "Net value of assets – net value of liabilities") (FY 2020-21, 2021-22 & 2022-23)
- (e) For the purpose of evaluation of the Bidder's compliance with the provisions of sub-paras (c) and (e) above. (Turnover, Net Worth) the estimated cost of the Works refers to the Employer's Estimated Cost as set forth in the Bidding Data shall be considered.
- (f) Registration certificate for Service Tax & valid Income Tax clearance Certificate /PAN No./ last 3 financial years Income Tax paid Certificate (FY 2020-21, 2021-22 & 2022-23).
- (g) The Bidder should be registered as a contractor/ equipment supplier/ vendor with the **GST** authorities at the time of submission of the bid.
- (h) PAN Card & GST Registration Certificate.
- (i) Registration under EPF.
- (j) Labour Contract License (if applicable).
- (k) **Money Receipt/DD/BG of EMD and Tender fee.**
- (l) ITR of last three assessment years duly certified by C.A.
- (m) Company Registration under Bombay Shop & establishment Act & Maharashtra Labour Welfare Fund (MLWF).
- (n) SSI Certificate (if applicable).
- (o) Insurance policy as per circular No.IR\Insurance\9623\Dt.13.4.2012 from the insurance company, Govt. of Maharashtra.
- (p) Solvency certificate valid for the current year from nationalized/ Schedule Bank for 20% of bid value.
- (q) Qualification of the Bidder (For Joint venture) Not Applicable for this tender.

10. Taxes and Duties:

11. Bidder shall indicate the taxes & duties against respective clauses in Annexure B without any ambiguity. In case, any of the taxes & duties is not payable, bidder shall indicate the reason thereof duly supported by documentary evidence.

12. Quotation :

- a) Each bidder shall submit only one offer.
- b) Bidder shall quote his rate in percentage as per schedule enclosed in Annexure 'A' in figures as well as in words. Any variation in the rate etc. will not be allowed on any ground such as mistake; misunderstanding etc. after the tender is submitted.
- c) In case of difference in the rates between the figures and words and/or if there is difference in the amount of taxes and duties worked out by Percentage calculations, then the rates Advantageous to company will be accepted.
- d) Tenderer's printed terms and conditions will not be considered as a part of the tender.
- e) The bidder is requested to ensure that the comments against each item / clause of Annexure/ Questionnaire shall be clearly filled in and answered. Any item/clause shall not be left blank or unanswered. If any item/clause is not applicable, the words "Not Applicable" shall be written against it.

13. Bid Validity

Bids shall remain valid for a period of **90 days** after the deadline.

In exceptional circumstances, the Employer may request the bidders to extend the period of validity for a specified additional period. The request and the bidder's responses shall be made in writing. A bidder may refuse the request without forfeiting his bid security. A bidder agreeing to the request will not be required or permitted to modify his bid, but will be required to extend the validity of his bid security for the period of the extension.

14. Bid Security (EMD & Security Deposit)

- A) The bid must be accompanied with Money Receipt of E.M.D. payment in the form of D.D. / Cash/BG.
 - a) Any bid not accompanied with adequate EMD will not be considered for evaluation.
 - b) The EMD of the unsuccessful bidders will be returned as soon as possible after completion of the bid validity period. The Bidder has to submit application for return of the EMD to this office.

- c) The EMD of the successful bidder will be discharged when the bidder has signed the Agreement and security deposit will be retained till completion of work.
- d) No interest shall be payable by MAHARASHTRA STATE ELECTRICITY DISTRIBUTION COMPANY LTD on the above EMD & Security Deposit.
- e) The EMD will be forfeited if -
- If the bidder withdraws his bid during the period of bid validity, or
 - In the case of successful bidder, if he fails within the specified time limit to Sign the Agreement.
- B) However, tenderers from the following categories are exempted from payment of earnest money deposit.
- 1) All Government and semi Government institutions under Govt. of Maharashtra and Zilla Parishad in Maharashtra and fully owned undertaking of any State Govt. and Govt. of India only for the items manufactured by Panel institutions.
 - 2) Small scale industrial unit permanently registered with Directorate of Industries, Maharashtra, only for the items mentioned in their permanent registration certificate.
 - 3) The tenderer registered with N.S.I.C. and those who have attached valid N.S.I.C. Registration Certificate at the time of vendor registration.
 - iii. The benefits mentioned in (1) to (3) above shall be available only to those items approved during the registration process and subsequent updates in registration up to the date of submission of this tender.

15. Format and Signing of Bid

- a) Only Digitally signed documents should be submitted.
- b) The bid shall contain no alterations or additions, except those to comply with instructions issued by the Employer, or as necessary to correct errors made by the bidder, in which case the person or persons signing the bid shall initial such corrections.

16. Submission of Bids

The tender is to be submitted online on or before the due date and time for submission on the website. It is advisable to submit the digitally signed bids sufficiently in advance of due date and time so as to avoid last minute trafficking at server. The prospective bidder should be well aware about the online submission of the bid. Any complaint for delay in submission of the bid due to any technical reason will not be entertained.

The tender downloaded from MSEDCL's website should be stamped & digitally signed on the mentioned pages as below and the same should be uploaded with the Technical Bid & Price Bid as mentioned below.

a. Technical Bid [Qualifying bid] (Part I) – online only

This part shall contain all technical and commercial aspects of the bid. The bidder should upload copies of scanned & digitally signed Technical Bid documents online and only the uploaded documents will be considered for qualifying the technical bid.

b. Price Bid (Part II) – online only

This part shall contain only the Price Bid strictly in the prescribed format i.e. Annexure-A, Price Schedule enclosed.

Commercial offer including price / activity schedule

To be in "Annexure A" of bid document with rates filled in both in figures and words and digitally signed by the bidder.

17. Deadline for Submission Bids

- a) Bid must be submitted not later than 24.00 hours on date: **29.01.2024**.
- b) The Employer may extend the deadline for submission of bids by issuing an amendment. The Employer also reserves the right to extend the bid submission date without assigning any reason. In such case (s) all rights and obligations of the Employer and the bidders previously subject to the original deadline will then be subject to the new deadline.

18. Late Bids

Uploading facility will not be available after the deadline.

19. Opening of Tenders:

Tenderer's are requested to submit their tender/offer with all the related documents online only on or before the due date and time for submission as mentioned in tender notice.

- ii) Telegraphic offer or offers received in the form of Telex or Fax message or by post in hard copy will not be entertained or considered under any circumstances whatsoever.
- iii) First, the **Technical bids will be opened online** on the date & time specified in presence of the tenderer/ representative of the tenderer who choose to attend the process online.
- iv) In case the date of opening of tender happens to be holiday the date of opening will be next working day at the same time.
- v) The **Price Bids will** remain unopened and the same will **be opened online** on the date and time as specified if possible. The price bids of only the technically qualified bidders will be opened.

17. Technical Evaluation of Bidders:

It should be noted that, Technical Bid documents submitted as mentioned above will be opened first. MSEDCL will examine the documents under Technical bid in accordance with the requirements with the bid document. If any of the documents under technical bid are not found to be complying with the requirement of the bid document, the bid will be considered as non-responsive and Price Bid of the corresponding bid will not be opened for further evaluation. Only the responsive tenderers of the technical bid shall be notified by the Employer to attend the online opening of the Price Bid of the bids.

If any of the minor deviation in submission of the documents under technical bid, the decision of the competent authority (Employer) will be final.

18. Process to be Confidential

Information relating to the examination, clarification, evaluation and comparison of bid and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process until the award to the successful bidder has been announced. Any effort by a bidder to influence the Employer's processing of bids or award decisions shall result in the rejection of his bid.

19. Clarification of Bids.

To assist in the examination, evaluation and comparison of bids the Employer may, at his discretion, ask any bidder for clarification of his bid, including breakdown of the prices in the Activity Schedules. The request for clarification and the response shall be in writing, but no change in price or substance of the bid shall be sought, offered, or permitted except as required to confirm the correction of arithmetic errors discovered by the Employer in the evaluation of the bids.

20. Correction of Errors

Bids determined to be complied with all qualifying conditions will be checked by the Employer for any arithmetic errors. The Employer will correct errors as follows:

Where there is a discrepancy between the amounts in figures and in words, **the amount whichever is lower will be governed.**

22. Prohibition for Post tender Correspondence.

The Bidder should note that no correspondence shall be entertained or considered after the due date and time of submission of tender unless otherwise sought by the Employer.

23. Prohibition for additions/alterations in SBD:

The tenderer shall not make any additions, alterations or changes in the Tender Form and the Terms & Conditions of Tender & Supply including the description of material mentioned in Price Bid. They should quote rate for the material described or click the checkbox 'Not quoted' against each of the item in Annexure 'B' / Price Bid.

24. Employer's right to accept or reject, any or All Bid(s).

The Employer does not bind himself to accept the lowest or any bid, neither will any reason be assigned for the rejection or part of bid. It is also not binding on the Employer to disclose any analysis report on bids.

25. Award of Contract

The Employer will award the Contract to the bidder whose bid has been determined to be substantially responsive to the bidding documents and who has offered the Lowest Evaluated Bid Price, provided that such bidder has been determined.

26. AGREEMENT

In the event of acceptance of particular bid for award of Contract such successful bidder has to submit **Contract Agreement** with applicable stamp value as per Maharashtra Stamp Act and security deposit. The Stamp fee as per Maharashtra Stamp Act over the value of Contract Awarded and other expenses of execution of agreement to be borne by Agency.

27. TIME: THE ESSENCE OF CONTRACT

The Contractor shall begin the Works on the Stated Date and is to carry out the Works in accordance with the program issued to him by executing officer ie concerned SDO time to time. Work-Order will be issued after signing of agreement with applicable stamp value as per Maharashtra Stamp act and submission of security deposit.

28. GUARANTEE:

The All services to be provided are to be guaranteed for correctness and conductance as per acceptable norms.

29. NOTICES:

Any notice to be given to the Contractor under the terms of the contract shall be served by sending the same by registered post or leaving the same at the Contractor's principal place of business (or in the event of Contractor being a company to or at its registered office.) Any notice to be given to the Employer under the terms of the Contract shall be served by sending the same by registered post at the Employer's address.

30. DETAILS: CONFIDENTIAL.

The Contractor shall treat the contract and everything contained therein as private and confidential. In particular, the Contractor shall not publish any information, drawings or photograph concerning the works and shall not use the sites for the purpose of advertising without written consent of the Executive Engineer, RASTAPETH Division, Pune and subject to terms and conditions as he may prescribed.

31. The company reserves the right to accept and admit any paper / documents which were necessary but remained to submit/upload by the bidder. In this respect, the company will have un-disputed discretionary powers to accept such papers / documents after opening of technical bid.

32. If the tenderer has any doubt about the meaning of any clause of the tender, he should at once get clarification from The Executive Engineer, Rastapeth division in writing sufficiently in advance and also personally meet him in this respect, before the due date. No additions or alterations in the tender form / conditions etc. should be made by the Tenderer. Objections if any from other agencies who have submitted their offers, after opening must be submitted in writing only on the day of actual opening of tender through e-process or max up to next working day. The complaints/objections in any form afterwards will not be entertained.

33. The contractor should have their office/Contact person in area under Rastapeth Division. The address along with the name of contact person and Telephone number should be furnished along with the offer.

34. The Contractor shall not entrust the work on sub contract, transfer or assign the contract or any part thereof to any other party without consent/permission from Executive Engineer, MSEDCL. In case if it is not followed, it will be treated as breach of contract and will be terminated at contractor's risk and cost.

35. As per the Government of Maharashtra Resolution, contractors' all risk (CAR) insurance policy or Transit cum Erection (TCE) or Erection all risk (EAR) insurance in respect of contract works awarded by MSEDCL as principle to the contract work and workman's compensation insurance in respect of workmen engaged and deployed by the contractor's to complete contract work, is required to be obtained from the Director of Insurance, the Govt. of Maharashtra as per the Letter from H.O. vide No. IR/Insurance/9623 dtd.13/04/2012.

36. All the work should be guaranteed for period of 12 months from the date of completion of work. Tenderer has to make good any damage, arising in guarantee period at his cost. Company's representative will permit reasonable time for replacement or rectification of work, failing which the Security Deposit / Bank Guarantee and retention money are liable for forfeiture to the Company. The MSEDCL may take legal actions accordingly. Maintenance shall be carried out during contract period being nature of tender work being day to day electrical maintenance.

The contractor shall at his own expense repair, rectify and make good to the satisfaction of the Engineer in charge all defects, imperfections, shrinkage or other faults arising from or out of the use of materials or workmanship not in accordance with the contract or from neglect or failure on the part of the contractor to comply with the provisions of the contract.

b) **Material used should be of approved make & good quality.** The materials procured shall be from reputed manufacturers or their duly authorized dealers / stockiest only. The materials shall confirm to the relevant I.S. Specifications. The materials shall also be got tested at an approved laboratory, at the cost of the Contractor to confirm suitability, before commencement of the supply.

c) The complete installation which the contractor has undertaken should confirm to the Indian electricity rules 1966, and the Indian electricity Act, 1910, with latest amendments and as per the specifications and standards laid down therein and as approved by the Engineer-In-Charge.

- 9) If it is found that the quality of work as well as performance is unsatisfactory the contract is liable for termination without giving any notice and at the entire risk of contractor. The security deposit paid in such cases shall be forfeited.
- 10) The contractor shall not entrust the work on sub contract, transfer or assign the contract or any part thereof to any other party. In case if it is not followed it will be treated as breach of contract and will be terminated at contractors risk and cost.
- 11) The material shall be arranged by the contractor and it should be as per IS Standard and should be approved by Company's authorized representative, before its use.
