TERMS AND CONDITIONS

**SEAL & SIGNATURE OF BIDDER**

1. The **crane should be registered in the name of contractor with RTO, All RTO, Formalities including permission from RTO/ Govt. Statutory Bodies, Tax. Payment, Insurance etc.** will be the responsibility of contractors.
2. **All relevant documents required under Motor Vehicle Act** in force shall to be produced before Executive Engineer (KLNR) Kalyan, as and when required.
3. The crane will hired for the period of up to 31.03.2025, **the value of contract being limited to Rs. 5.00 Lakhs** only. In case the contract does not materialize or is not materialized in full/part, the contractor will not be given any compensation thereof and the contract will stand terminated at the expiry of contractual period without any liability on the part of the MSEDCL.
4. The contract can be terminated in between be giving notice if the service is not found satisfactory.
5. The contractor shall not affect the transfer of contract to any other party. In the event of violation of this clause, the contract will be liable for termination without any notice and without any liability on the part of the MSEDCL.
6. The contract can be renewed beyond the **contractual period of up to 31.03.2025** as per requirement of the MSEDCL, if agreed upon by both the parties.
7. The condition of the crane should be good Hook slings D shackles of required capacity for loading / unloading operations will have to be arranged by the contractor.
8. The crane of required capacity should be made available immediately on requisition by concerned Executive Engineer. If the crane of required capacity is not available at depot or is engaged elsewhere at that time, the contractor should make an alternate arrangement to send the crane of same capacity or higher capacity as per requirement of concerned Executive Engineer at the same rates and Terms and Conditions of the contract.
9. The contractor shall keep the crane in good working conditions always during currency of contract. **In case of break down of crane, the contractor should make alternate arrangement of crane** to fulfill MSEDCL requirement. The alternate crane should also be in good condition and should be of the same or higher capacity and at the same rates Terms and Conditions of the original crane requisitioned.
10. **The Driver – cum – operator posted in the crane should possess valid permit as per RTO Rules.** He should courteous in behavior and good mannered.
11. No tools and plants will be provided by the MSEDCL All tools tackles or manpower required for carrying out the work at site or elsewhere shall be provided by the contractor.
12. **The MSEDCL will not be responsible for any damage/loss to the crane or to the Driver – cum – operator and cleaner or any outside party during the validity of contractor period.** Any loss/damage to the MSEDCL property and injuries to the staff or persons occurring due the crane shall be made good at the cost of contractor and at the cost decided by the MSEDCL/ Authority.
13. **Comprehensive risk as per Motor Vehicle Act should be covered properly.**
14. The operation of the crane will be entirely at the risk, cost consequences of the contractor.
15. The contractor should strictly follow rates and regulations of traffic police.

16. **The contractor must carry the time sheet when the crane is hired by our SDOs.** After completion of work the contractor will have to fill up and obtain the signature of concerned SDOs / Field Engineer In charge on the time sheet immediately. The contractor shall be solely responsible and maintain all details (such as location of work, Nature of work, duration of work etc.) for every trip of the crane to respective SDOs.
17. The Earnest Money Deposit will be liable for forfeiture :
  - a. If the contractor fails to pay the Security Deposit.
  - b. If the successful contractor refuses to sign and complete contract document and agreement and further to execute the contract. No EMD is taken from "A" and "B" class contractor of the board provided they submit documentary evidence to the effect that they are registered with the MSEDCL / erstwhile MSEB.
  - c. In case the offer is withdrawn by the contractor after opening but before expiry of 90 days prescribed validity period or in the event of refusal to accept the order for work of if the refuses to pay Security Deposit as per clause No. 18 above.
18. **Income tax as the rate fixed by the Govt. from time will be deducted from the bills as per rules.** Also statutory rates and taxes such as work contract tax/service tax etc will be on the contractors account.
19. In case of any disputes regarding Terms and Conditions or any other point decision of the Executive Engineer, Kalyan Rural Division will be final and will be bound on the contractor.
20. Any amount of damages or expenses or any other amount under this or any other contract payable by the contractor to the MSEDCL may be deducted by the MSEDCL from any amount due or becoming due by the board to the contractor under the same or any other contract without prejudice to the board's right to recover the same by ordinary process of law.
