GENERAL TERMS & CONDITIONS OF TENDER**

- 1) **EARNEST MONEY DEPOSIT** : All Tenderer's are required to pay E. M. D. as per existing rules to the extent of 1% of the estimated value of the Tender.
Mode of payment : E.M.D. may be remitted up to Time & Date mentioned earlier at our office by Cash/D. D./B.G.(Valid for 150 days) of any Nationalized / Scheduled Bank, in the name of Executive Engineer, O & M PANDHARKAWADA division E. M. D. remitted in any other than prescribed form will not be accepted.
The Tender offer without E. M. D. will be liable for rejection.
- 2) **eTENDER PROCESSING FEE (COST OF TENDER)**: All Tenderer's are required to pay Cost of Tender as mentioned earlier ONLINE only. Tender Cost remitted in any other than prescribed form will not be accepted. The Tender offer without Cost of Tender will be liable for rejection.
- 3) **REFUND OF EARNEST MONEY DEPOSIT**: Bidder should surrender the original Money Receipt issued by this office to facilitate refund of E. M. D. Therefore, the Bidders are advised to preserve the Money receipt properly. Bidder should submit the application along with original money receipt for refund of E. M. D. No interest will be payable by the purchaser on the E. M. D.
- 4) **VALIDITY**:- The offer shall remain valid for 120 days from the date of opening. Thereafter also, it will be treated as valid until withdrawn by the Tenderer by giving notice in written to this office.
In case, the Tender offer is withdrawn between date of opening & expiry of **120 days** of validity period or in the event of refusal to accept the order or to pay the security deposit as per clause within stipulated period as mentioned in detail order, the E. M. D. deposited by the Tenderer will be forfeited & no claims there off will be entertained.
- 5) **LIQUIDATED DAMAGES: (PENALTY)**
 - a) **Wrong Billing**:
If any discrepancy is observed by MSEDCL while cross checking the readings taken by the Agency, penalty as per the circular of MSEDCL per case shall be recovered from agency for each occurrence
 - i) The agency should take 100% meter reading. The normal billing percentage should not be less than 95% audit will be binding on the agency. If any deviation in the percentage below the 95% of meter reading, the double penalty will be imposed as per the rule of MSEDCL.
 - ii) If any instructions received from higher authority time to time regarding percentage of normal billing, accordingly it will be binding on the agency to maintain normal percentage meter reading otherwise the penalty will be imposed as per the rule of MSEDCL.
 - iii) If the agency provided the lock status reading & it's no of consumer thereof, accordingly the reading provided by MSEDCL staff against the lock status, then the amount of penalty per no of consumer should be deducted from agency as per rule.
 - b) **Delay Bill**:
Bill must be distributed three days before incentive date otherwise Rs 2/- (two) per bill per delayed day subject to maximum of 25% of the bill amount shall be deducted as penalty.
 - c) Similarly, we also penalize if the normal billing is below 95% and the rate of penalty will be as MSEDCL's Rule and as per instructions of Competent authority.

(A Normal bill shall display a clear Meter reading , Meter Serial Number, Consumer no, Billing Unit No and DTC code on the sticker are visible in the photograph and the same reading is punched). If sticker is missing, it should be provided by agency during same billing cycle.

- d) Non distribution of bills: Rs 20/- per non distributed bill on written complaint from consumer. If bills in bunch, undistributed and found lying at pan shop, tea shop or anywhere else a lump-sum fine of 25% of bill amount for that period shall be levied. Second such instance may lead to cancellation / termination of contract and forfeiture of Security deposit
- e) If Normal meter is shown "Faulty", and it is noticed in cross checking/ consumer complaint / or found Normal in subsequent billing cycle, the Penalty of Rs 100/- per case shall be imposed.
- f) The essence of this contract is that the Contractor issues the bills to the consumers in stipulated time period and also that the bill is absolutely correct in all respects. Thus it will be mandatory on part of the Contractor to carry out the work of allotted quantity as per the scope (in totality) and as per the billing cycle of the respective sub-division within the specified time. A weekly compliance shall be given by the Contractor to the respective Executive Engineer / nominated authority, in case of failure to carry out the allotted quantity of work / issue the bills within the stipulated time period,
- g) In case the Hon. Regulatory Commission penalizes MSEDCL, & levies penalty / fine on account of non-compliance of Standard of Performance with respect to the bills issued under this contract (delay or wrong bill or for any other reason pertaining to billing), and where the Contractor is responsible for this, the same penalty / fine shall be to the account of the Contractor and it shall be deducted from the bills of the Contractor. **If the wrong billing exceeds 5% (in quantity) during a particular month, the contract is liable to be terminated** and MSEDCL shall be entitled to deduct/recover the amount of liquidated damages from the bills payable to the Contractor or any other amount due or payable to him against this or any other contract (Deduction of one Division against the payment of any other Division for the same Contractor) The total penalty will be limited upto 25% of contract value.
- h) These Penalty will be without prejudice to MSEDCL's rights of any other action / recourse permitted under the law.
- i) No payment will be released for R.N.T. If R.N.T. status increases above 1% then additional penalty of Rs. 5 per consumer will be imposed
- j) The agency should co-ordinate with MSEDCL/agency engaged for faulty / stop meter replacement and other abnormality if observed
- k) The agency should coordinate with section office / Sub Div. Office before starting the reading program to make meters accessible and for meter replacement report so as to stop average billing.
- l) **If agency brings billing less than 95% (or as per directives of competent authority) of normal billing continuously for more than two months / two billing cycles then their contract will be liable for termination.**

6) **Payment of Bills:**

6.1 The payment shall be generally made within 60 days (Sixty) from the date of submission of clear invoices. The Contractor shall submit the original bills / invoices in triplicate to the respective sub-division office for recording the same in the ERP. The said sub-division office shall forward the bill through ERP/SAP to the Executive Engineer of respective division office who in turn will make the payments.

6.2 **Web console reading Job status report will be considered only for making payments.** The contractor should bring readings of all the consumer in the particular P.C.

6.3 No payment will be released for R.N.T. If R.N.T. status increases above 1% then additional penalty of Rs. 5 per consumer will be imposed.

6.4 The copy of billing program given by sub division & copy of billing program executed by agency should be submitted with bill with job finished status.

6.5 The generated reports in soft copy should be handed over to respective billing unit & the receipt of the same should attach with the Quarterly bill. Without receipt of report handing over the bill not be processed.

6.6 I.T. report of billing status of respective P.C. should be attached with the bill otherwise the bill not be processed.

6.7 Income tax will be deducted from the Quarterly bill as per rules of Income Tax.

6.8 Contractor shall submit Goods & services tax challan & P.F. challan along with subsequent bills.

7) Sub-letting the contract to any other party will not be permitted.

8) For improper execution of the contract, the S. D. held with Company will be forfeited.

9) The value of this order is as mentioned earlier. However Goods & Services Tax as applicable will be paid extra.

10) The contractor's bill will be subject to recovery of Income – Tax (at source) as applicable & other statutory recovery, if any.

11) Any amount or amounts which becomes payable by the supplier to this office under particular contract may be deducted by this office from any amount / amounts due or becoming due for payment by this office to the supplier under the same or any other contract with M.S.E.D.CO.LTD.

12) **TERMINATION OF CONTRACT** :- The under signed reserves the rights to terminate the contract / order at any stage without assigning any reasons thereof.

13) Conditional tenders will be rejected out rightly & earnest money is likely to be forfeited.

14) Tenderer is requested to go through the tender documents carefully & if the any doubts regarding the meaning of any clause of the tender or of the specification, he should contact the undersigned & get it clarified in writing before tenderizing. If any point is raised after tendering or during the contract period, the verdict of the undersigned thereof will be final & binding on the contractor.

15) The interpretation of the undersigned on any matter or decision on any disputable points will be final and binding on the contractor.

16) **Tenderers should sign "Annexure A" in token of having read & accepted the all tender conditions.** They should also fill in all details as asked in tender & should be submitted while tendering.

17) All disputes or differences arising under, out of or in connection with the contract, if concluded shall be subject to the exclusive jurisdiction of the PANDHARKAWADA Court only.

20) This work should be carried out as per the directives of concerned Divisional/Sub-Divisional officer.

22) The MSEDCL reserves the right to add/omit any term/terms found necessary for the work or to cancel the full order without assigning any reason.

23) **Security Deposit:** The contractor whose tender has been accepted shall be required to deposit 5% of the order value as security deposit (S.D.) in the form of Cash / B.G. within 7 days of intimation of acceptance of Tender. Balance 5% will be recovered proportionately from R.A. bills. Failure will result in forfeiture of EMD.


