3.1 The bidding is open to individual or Joint Venture bidders who satisfy the qualification criteria set forth in the bidding documents with respect to their experience and financial capabilities. The joint venture partnership agreement is treated as valid up-to completion of work & even upto refund of S. D. and it is responsibility of all the partners to complete the work, even though the partnership is broken during the period of work.

3.2 General Experience:

Bidder should have executed/completed either-

- One work** order equivalent to minimum **20%** value of tender or.
- Two works** order of together value not less than **25%** of value of tender or.
- Three works** order of together value not less than **30%** of value of tender, during last preceding five years.

In case of Joint Venture, the condition of General Experience should be met by the lead partner.

However, this criterion can be relaxed by the competent authority, if the bidder is having capacity (on the basis of relevant documents submitted by him) to undertake such works.

3.3 Tenders without following terms & conditions / submitted without copy of the Money Receipt (M.R.) at our Office for the payment of E.M.D/ Incomplete tenders or submitted with incomplete documents will not be considered. Decision of the CGM, T&S, Nashik in this respect shall be final and binding to all.

3.4 The rates quoted will be considered firm for minimum **120 days**.

3.5 Bidders not fulfilling the criteria of submission of the technical bid documents as specified above will be disqualified. For participation in the tenders, bidders have to purchase the tender from this office online.

3.6 The on-line purchase of tender documents does not necessarily qualify the bidders for acceptance of their bid.

3.7 The tenderer should submit complete tender document with Technical bid i.e. page no. **1 to page no.21** as Technical Bid. Definition and Meanings of terms and abbreviations used in the tender specifications.

- a) The "Company" means the Maharashtra State Electricity Distribution Company or Chief General Manager (T & S) or his authorized representatives.
- b) The word "Contractor" means the successful bidder who has been awarded the contract against this tender.
- c) The abbreviation "T & S" stands for the Department of Training and Safety of M.S.E.D.C.L.
- d) The term "E.M.D." means Earnest Money Deposit.
- e) The abbreviation "S.D." means Security Deposit.

1. General Information

- a. The Maharashtra State Electricity Distribution Company Ltd. is having a Training Complex for its Staff/Employees at **premises of Regional Training Center, Chhatrapati Sambhaji Nagar.**
- b. The Training Centre is provided with Hostel for lodging and boarding facility of Company's employees deputed for training from all over the Maharashtra and there are faculty members also.
2. **Only reputed and experienced contractors having said experience in providing catering services are requested to submit their offers against the tender in two Bid systems as stated in the Tender Notice attached with this booklet. And only those agencies are to submit their bid, who having the experience & capacity to provide catering services to minimum 60 persons at a time & experience of works at Training Institutes & Reputed company's canteens for providing Tea, breakfast, lunch & dinner facilities.**
3. The bidder is requested to note that the offer is to be submitted on- line for the **work of Providing Catering Services at premises of Regional Training Center, Chhatrapati Sambhaji Nagar.** The bidder shall submit the information and documents necessary in Technical bid.
4. In absence of documents to be furnished in Technical bid, the tenders shall be liable to be rejected. As such the tenderer shall ascertain and satisfy their own interest that they fulfill all the pre-qualifying conditions.
5. The Price Bid should be submitted in formats in Commercial/Price Bid. The bidder shall quote his percentage rate for these services in Price Bid in the space provided for the same. The rate quoted shall be firm and shall be applicable throughout the period of contract.
6. The tender offer is invited for Catering work of Hostel Canteen. The offer is to be submitted as below-
 - 6.1 The percentage rates shall be quoted for the various food items or menu involved, including cost of all grain material, cooking gas, serving & cooking utensils, cook, helpers, etc.
 - 6.2 The basic approved food rates of this office are shown in enclosed **Annexure II.**
 - 6.3 The Contractor shall also ascertain the difference of cost hike for all related raw material items, vegetable items, labour cost on account of cook & helpers etc. and **accordingly quote the offer rates for each food Items in PRICE BID.**
 - 6.4 Nothing extra will be paid on any account, except additional items ordered by the management, based on mutually agreed rate.
7. **The Contractor has to provide Good Uniform to persons attending the trainees and faculties directly and maintain the same neat & clean. The penalty for non-wearing of uniform shall be levied @ Rs. 50/- per person per day.**
8. The bidder shall furnish full and complete information with tender. Incomplete tenders/offers and tenders not signed by the bidder or bidder's authorized representative are liable to be rejected and no claim on this account will be entertained by the Company.
9. Tender document shall be written legibly and free from erasing, over-writing, corrections and wherever inevitable it shall be duly signed with date.
10. Before submission of the offer, the tenderers are requested to scrutinise all the terms and conditions mentioned in the tender specification thoroughly and visit the site of works and get fully acquainted with the scope/specification, local conditions and other factors having bearing on rates for execution of the work.
11. **Payment of E.M.D.:** An EMD at 1% of the Tender value shall be paid online. - 12. (e) In case of Joint Venture if there is any breach in the Joint Venture before finalization of tender & issue of LOA within original or extended period of validity of the bid. (Note: People distract the other tenderer by quoting very low price bid & It is experienced that the services of the bidders had to be terminated due to supply of poor food quality and service & resulted in imposing penalty, forfeiting the security deposit, recovering the difference in price and overhead charges).

- 13. Security Deposit:** Successful bidder will have to pay the Performance Security Deposit @ **10% of the contract value** & S.D. valid till successful work completion period within 7 days of issue of LOI. either in Indian Rupees or in the form of unconditional and irrevocable Bank Guarantee from Nationalized or Scheduled commercial Bank payable at Nashik Branch only.

If the successful tenderer fails to sign the contract in accordance with the conditions of the contract and/or to furnish prescribed security deposit within stipulated time limit (7 days), the Letter of Intent shall be cancelled and his earnest money deposit shall be forfeited.

Section– II

Scope of work and Terms & Conditions of Contract

1. Scope of work of this contract is managing catering services at **premises of Regional Training Center, Chhatrapati Sambhaji Nagar** as per Schedule of service [Annexure-I] attached herewith.
2. The **basic approved schedule rates** of tea, breakfast, meals etc. are shown in the list attached herewith as Annexure II. **The contractor shall quote his rates on the basis of present market value of desired best quality material required for food i.e. grain, vegetables, milk etc. and labor considering the future inflation.** The rate quoted by the contractor in **COMMERCIAL/PRICE BID** shall remain valid for **complete contractual period/One year**. The contractor shall not charge more than the rates prescribed on account of any reason.
3. Contractor shall coordinate and discuss for daily/ weekly food menu with Section head / Batch coordinator / **In-Charge i.e. Add. Executive Engineer, RTC Chhatrapati Sambhaji Nagar** in advance to avoid the complaints of students for repetitive food menu. Contractor shall maintain the food register regularly and shall be got endorsed.
4. Company will **not** provide cooking gas & utensils for use in kitchen or dining hall. Contractor shall arrange the same at his own cost & maintain in good, clean and hygienic condition. If possible in future, company will arrange for Freeze, Microwave, etc. for use in Canteen at no extra cost to contractor, so as to facilitate to training participants. Contractor has to arrange for proper up-keepment of the same and to keep in good working condition. Any loss/damages to the contractor's utensils will be the responsibility of the contractor.
5. If found necessary in the opinion of contract operating Authority, samples of eatables will be tested by the representatives or Food committee members of the office or department of Food & Drug as and when required. Contractor should bear the cost of such testing charges and suggestions given in this regard should be implemented, otherwise it will be viewed seriously action deemed fit shall be taken by this department.
6. **If any type of Food Poisoning or other problems due to bad quality of Food are raised, Contractor will be fully responsible for the problem and in this case legal action will be taken against the contractor.**
7. Licenses required for this work should be obtained from Govt./ Local Competent Authorities by the contractor at his own cost.
8. All eatables should be prepared with good quality of material with prescribed brands and in good quality of branded and tin-packed Sunflower/Groundnut oil / Vegetable Ghee only as approved by the Engineer-in-charge of this office. Sanitary conditions inside the kitchen, Store room, Dining hall and surrounding will have to be maintained to the satisfaction of the contract operating authority from time to time as per statutory laws, rules and regulations.
9. Contractor must ensure providing clean kitchen, dining premises and tables in Dining Hall.
10. Contractor must ensure hygienic, hot and tasty food in the dining hall. Sufficient distribution set for buffet Lunch /Dinner shall be arranged by the contractor. In case of number of trainees increase than normal capacity, contractor shall arrange for additional set of distribution containers at his own without any extra cost.
11. If required and instructed by the Add. Executive Engineer (Dist.), Nashik or their representatives the contractor shall have to arrange himself the additional furniture, vessels, crockery, thermos etc. for the efficient catering services.
12. Recovery of dues from any customers/trainees, if any in case, shall not be the responsibility of the Company.
13. The contractor shall use L.P. gas at his own cost and risk and maintaining all safety conditions. The use of other fuels such as coke, coal, wood, kerosene is not permitted.
14. The Rate Board mentioning all items and rates thereof as per approved rates by the competent authority should be strictly displayed daily and contractor should serve the items as per demand on the same rates.
15. **Drinking Water:** Drinking Water Purifier & Cooler is provided at Dining Hall at Regional Training Center, **Chhatrapati Sambhaji Nagar**. Contractor has to provide Drinking water to all on tables without any extra cost. Care should be taken that the contractor's servants should not dip the fingers in drinking water while serving.
16. Serving of any **alcoholic drinks, tobacco products** in Regional Training Center, **Chhatrapati Sambhaji Nagar** premises is strictly prohibited.
17. If required and instructed by competent authority, contractor shall have to arrange himself material/ manpower/special servicing utensils for buffet Lunch/ Dinner for at least two groups simultaneously in the dining halls.
18. If ordered, contractor should prepare and serve food items required for 'UPWAS/FAST' during Lunch/ Dinner timings.
19. **Terms of Payments:-**

- a. Bill shall be submitted in triplicate and in % GST format only with duly printed GST No., SGST & CGST amount bifurcation on it. It should be submitted **batch-wise / month-wise** by the contractor. Alternatively, for long tenure batches calendar month bill may be submitted with proper record and concurrence of Section head / Batch coordinator / **In-Charge i.e. Add. Executive Engineer, RTC Chhatrapati Sambhaji Nagar.**
- b. Bill for every month (as per scheduled batches) should be submitted up to the date 5th of next month OR on the fifth day after completion of each batch compulsorily.
In case of any financial implication aroused on account of delay in bill submission; MSEDCL will not be responsible.
- c. 100% payment will be made by this office through RTGS in reasonable time as per availability of funds & HO CPS payment terms on submission of bill in triplicate either on monthly R.A. Bill basis.
- d. Payment will be made after recovering Income Tax as per prevailing rates applicable. [T.D.S. will be deducted as per Govt. Rule].
- e. All efforts will be made to release payment within reasonable period from the date of submission of clear bill. However, this period may vary due to unforeseen circumstance beyond the control of this office and company will not pay any interest for delay thereof. The contractor may please note the same.
20. The company will not be responsible for any accidents to any person engaged by the contractor and hence it will be duty of the contractor to ensure safe working and safety of his personnel. The contractor has also to comply with the Workmen's Compensation Act or any other Act in force as applicable. The Contractor shall indemnify the Company for any such claims against any injury, damages, loss etc.
21. Contractor shall ensure the Group Insurance to cover all workers employed by him.
22. As per the Govt. of Maharashtra's various G.R.'s (specifically Dated: 29.04.2011), Workmen's Compensation Insurance in respect of contract works awarded by MSEDCL to contractor, is to be obtained from the M/s. National Insurance Company Ltd. who is authorized by the Director of Insurance, Govt. of Maharashtra, Bandra. Also all Rules, Regulations, G.R. of Central Govt. /State Govt. will be applicable to this tender and its related work order.
23. Equipment fittings, fixtures, furniture and other asset whichever handed over to agency at the time of commencement of contract shall remain the property of the MSEDCLtd. Contractor shall be the custodian of these assets during the period of contract. After completion / termination of the contract, the contractor shall hand over these equipments, items/ assets in good working condition back to **In-Charge i.e. Add. Executive Engineer, RTC Chhatrapati ambhaji Nagar** or Company's (authorized) representative of Chief General Manager (T&S), Eklahare, Nashik.
24. Contractor shall be responsible for safe custody, proper use and maintenance of all assets as above of the Company whether movable or immovable.  - d. *Food workers physically distancing in the work environment.*
 - e. *Steps taken if food worker contagious disease illness in the work place.*
 - f. *Steps taken food worker transport and serving the good ingredient and preparing the food.*
 - g. *Food worker staff confine high standard of public measure for hand washing and respiratory etiquettes need to be maintained at work canteen.*
 - h. *Continues to monitor the situation closely, provided catering services.*
29. The detailed information about all staff shall be submitted at this office by the contractor immediately on commencement of contract. Any change shall also be informed and got approved from Executive Engineer (Admin) Department of Training & Safety, Eklahare, Nashik. No person other than approved staff shall work or monitor on your behalf in Training complex, otherwise it will be viewed seriously and action deemed fit shall be taken by this department. And it is mandatory for you to submit the detail identity proof & police verification of the staff engaged by you in the above said catering contract.
30. The Contractor shall be responsible for the improper behavior of his staff, not only amongst themselves, but also with Companies employees & trainees and exercise proper control over them and prevent them from acting in

- any way detrimental or prejudicial to the decorum and smooth functioning of training center and Hostel complex.
31. The contractor shall serve food/meal to trainees, MSEDCL employees (food committee members) , guest faculties only. In any circumstances the Contractor should not serve food/meals to outsiders without prior permission of the Competent Authority.
 32. The complaint book should be kept and made available to customers immediately on demand for noting down the complaints if any. The complaint book should be produced to the contract awarding authority as and when required and instructions, if any, thereof, should be followed strictly by the Contractor. If complaints regarding quality of food arise from trainees & found justified, you will be informed & if the same are not corrected, your order will be terminated by giving 3 days' notice period.
 33. It will be the responsibility of the contractor to follow labour laws, payment of wages Act 1936, Workmen's Compensation Act.
 34. The contractor shall pay minimum wages, to all labour.
 35. The Contractor should follow the instructions as given time to time by the RTC In-charge i.e. Add. Executive Engineer (Dist.), RTC / Batch Coordinator / Caretaker & Food Committee Members.

 43. **If rates of two or more bidders are found equal, the bidder with experience & good service will be given priority for order. However, the decision of Competent Authority will be final and binding to all bidders.**
